All membership applications must be approved by the Walla Walla Yacht Club Board of Directors, which meets monthly. You will be on a waiting list which is kept on a first-come basis. At a specified time, you will be invited to a New Membership Orientation where you will also be introduced to the Board. As slips become available for boats your size, you will be contacted. For more information, contact the Commodore or the Secretary.

**Membership Liability Insurance:** Proof of liability insurance shall be required from each membership for each boathouse, boat, jet ski, and/or other motorized watercraft owned and operated at Walla Walla Yacht Club. Proof in the form of a copy of the declarations page received from the insurer shall be submitted with the annual payment of dues. A liability limit for each accident, bodily injury and property damage not less than \$300,000 coverage shall be required. Proof of liability is required upon acceptance of your membership to be included with your fee payment.

WWYC assumes no liability for personal property (boathouses, boats, other watercraft), and personal belongings. Members and guests use club facilities at their own risk.

>> Moorage is not transferable with the sale of a boat or boathouse.

**>> Annual moorage fees and workhours are NOT PRORATED in any manner.**

>> The Board of Directors reserves the right to rearrange moorage.

>> The work hour year begins on November 1st of the current fiscal year and ends the following October 31st.

**>> A deposit of \$50 must be included with your application and is refundable upon your request.**

>> Balance of your fees is due no later than 10 days after acceptance before next applicant may be contacted.
